WHAT DOES CDS1 SECURITIES LLC (THE "FIRM") DO WITH YOUR PERSONAL **FACTS INFORMATION?** Why? Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. This information can include: Social Security number and income; Account balances and transaction history; and Credit history and credit scores How?
